

INTERVIEW SUMMARY of **SONNY (SONNY) CHHOUN** Telephone **012 877 307** and **096 720 5219** at SIEM REAP March 6, 2014 1530 to 2000 regarding matters preceding and subsequent to the disappearance of **DAVID (DAVID) WALKER** on or about 1400, February 14, 2014.

SONNY and **DAVID** are very close friends in business and socially. Their relationship spans over a year. (Associates and others known to them have remarked that they view **SONNY** and **DAVID** as "one")

DAVID does not drink alcohol, engage in recreational drugs or smoke. **DAVID** has no romantic relationship or engage with prostitutes. **DAVID's** sole interests are in his work and his social life is closely related to his work.

For approximately 7 months prior to Feb. 14, 2014 **DAVID** had entered into and maintained meetings with **Andy (AL) Long** and **Mao (MS) Salao** regarding obtaining investment monies of USD 3,200,000 (three million, two hundred thousand U.S. Dollars) for the funding of **DAVID** and **SONNY's** proposed film project "ANIMIST FARM".

SONNY repeatedly warned and strongly advised **DAVID** against any association or dealings with **AL** and any entity associated to **AL** because of the past unlawful activities and suspected current unlawful activities of **AL**.

However **DAVID** disregarded **SONNY's** assertions because **AL's** associate in these dealings was **MS** with whom **DAVID** had previously met and developed a close and trusting close friendship in Canada.

SONNY refused to attend or participate in any dealings with **AL**. **SONNY** maintained his warnings of **AL** to **DAVID** however **DAVID's** belief that his trusted friend **MS** and **MS's** associate **AL** could provide all or part of the investors with the required investment monies, monies that were seen to be derived from legitimate sources free of being derived from criminal activities or enterprises, for the project.

DAVID was adamant in his statements to **SONNY** that investment monies for the project had to be legitimate and remained convinced that **MS** and **AL** were providing legitimate investors with legitimate investment funds.

At or about 1800 on February 12, 2014 **DAVID** met with **AL** and **MS** at the 'Karma Bar', Sok San Road where **SONNY** believes matters of the investment monies were furthered.

At or about 1700 to 1800 on February 13 **DAVID** again attended a meeting at the 'Karma Bar'.

Information later derived from **DAVID's** mobile telephone (Mobitel # 012 877 307) by **SONNY** describe that on February 13, at about 2100 calls were made from and to **AL**.

During the day of February 14, 2014 **SONNY** began telephoning **DAVID** to confirm that he and **DAVID** would attend, as preplanned, a concert at the Thimomakia Temple however all calls and later text message remained unanswered.

At or about 2000, February 14, **SONNY** went to the Green Village Angkor Guest House to see **DAVID**. Upon his arrival he spoke to the young man at the reception area inquiring as to whether **DAVID** had been observed and had the receptionist accompany him to **DAVID's** room.

Upon entering **DAVID's** room **SONNY** called **DAVID's** name several times but received no answer whereupon he then searched the room and the room's accompanying bathroom for **DAVID**.

DAVID was not in the room however **SONNY** observed **DAVID's** mobile telephone attached to its charger on the bed, **DAVID's** MacBook computer in sleep mode freshly cleaned laundry that **SONNY** presumed **DAVID** had picked up from the laundry located near the guest house that same day and **DAVID's** bag. (**DAVID's** Passport was later found by **SONNY** within the bag.)

By this time **SONNY** became worried as to **DAVID's** whereabouts as the events and circumstances were showing to be out of context to **DAVID's** usual patterns of behavior and most extraordinary **DAVID** not responding to telephone contact with **SONNY**.

SONNY then began questioning the receptionist regarding any sightings of **DAVID** that day whereupon **SONNY** was told at between 1100 to 1200 **DAVID** departed to have breakfast at the 'Five Sons' restaurant



as was his habit and then retrieve his laundry however he was away for several hours because it is believed by **SONNY** that **DAVID** would have spent some further time conversing with a particular woman working at the laundry who, although she is Cambodian, she also speaks Thai which is a language **DAVID** is conversant with and allows him to use the language while in the company of this female.

At about between 1300 to 1400 **DAVID** returned to his room and as was later stated by the cleaner, at about 1400 **DAVID** left his room to allow the cleaner access to his room however **DAVID** was NOT seen leaving the guest house, ** This contradicts media reports **DAVID** attended the 'Five Sons' restaurant at about 1400**.

On Feb. 15 about 1800 sonny

After 1500 **SONNY** then made further inquiries at the 'Five Sons' restaurant where he confirmed what had been stated by the receptionist.

For the remainder of the day **SONNY** maintained searching for **DAVID** in the area and at venues normally visited by **DAVID** and **SONNY**, making inquiries of **DAVID's** whereabouts from persons they know, returning to the guest house several times to ascertain whether **DAVID** had returned. **SONNY's** searches and inquiries proved negative.

On February 15, 2014 **SONNY** maintained his searches and inquiries of **DAVID**. **SONNY** was also demanding the Green Village Angkor Guest House report the matter to Police as a matter of urgency however on each occasion he was rebuffed and told, "don't worry **DAVID** will turn up". (It is incumbent upon the guest house to file a missing person report with the Police.)

On February 16, 2014 **SONNY** having become extremely worried about **DAVID** and further frustrated and angry by the refusal of Green Village Angkor Guest House to report the matter to Police confronted the guest house receptionist to the extent whereupon the receptionist accompanied **SONNY** to **DAVID's** room and the receptionist obtained **DAVID's** Passport after which **SONNY** then told the receptionist to file an official Missing Persons Report with the Police.

Again the receptionist refused.

For the remainder of that day **SONNY** also maintained his search and inquiries of **DAVID**.

On February 17, 2014 **SONNY** visited the Green Village Angkor Guest House to ascertain whether the guest house had completed the Missing Persons Report with Police and learnt from the receptionist no report had been filed whereupon **SONNY** then had the receptionist again accompany **SONNY** to **DAVID's** room and **SONNY** acquired **DAVID's** mobile telephone after which **SONNY** obtained the numbers stored and began calling all numbers recently shown to assist in attempting to locate **DAVID**. The most prominent numbers being those of **AL** and **MS**.

SONNY carried out several telephone conversations with **MS (093 818 128)** From February 17 during which **MS** stated he had no knowledge of the whereabouts of **DAVID** and was totally disinterested in discussing any matters regarding **DAVID** or **DAVID's** disappearance which surprised **SONNY** as **MS** was supposedly a lifelong close friend to **DAVID** for over 30 (thirty) years. **DAVID** had placed complete trust in **MS** and would not have entered into any arrangement with **SL (088 999 8181)** and **MS** had it not had the substantial credit worthiness **MS** had **DAVID** believe in **SL**.

It was very odd that a lifelong friend, **MS**, of complete trust would display such disinterest in the whereabouts and wellbeing of his friend **DAVID**.

On February 18, 2014 **SONNY** again visited the Green Village Angkor Guest House to ascertain whether the guest house had yet completed the Missing Persons Report with Police and learnt from the receptionist no report had been filed whereupon **SONNY** then proceeded to the Solac Comret Commune Police station where he initiated an official, formal Missing Persons Report during which the Immigration Police were alerted and then attended further accompanying **SONNY** back to the Green Village Angkor Guest House where **SONNY** understands they commenced official inquiries in response to **SONNY's** report.



However **DAVID's** room was not officially sealed or designated a crime scene although by this time **SONNY** commenced to believe **DAVID** may have been abducted while at the Green Village Angkor Guest House and was the victim of foul play.

There is egress through the rear of the guest house which leads to the proprietor's residence then through to a rear street access.

Regardless of the aforementioned **SONNY** believes the matter was not being treated seriously and was not receiving the attention by the Police that was warranted.

For the remainder of that day **SONNY** also maintained his search and inquiries of **DAVID**.

On February 19 the disappearance of **DAVID** was made public by media sources based on the Missing Persons Report **SONNY** had initiated however the media reports and Police press releases contained erroneous information regarding the events surrounding **DAVID's** disappearance and made no mention of the efforts of **SONNY** to have the matter disclosed and the work **SONNY** was doing in assisting to locate **DAVID** and have the APPROPRIATE law enforcement authorities confront persons who **SONNY** alleges may be involved with the now suspected abduction of **DAVID** namely **Andy (AL) Long and Mao (MS) Salao** and those who may have assisted the alleged perpetrators in the matter.

Various media reports have stated incorrectly **DAVID** and **SONNY** co-own undeveloped property about 2 hours outside Siem Reap which they dubbed "Animist Farm".

The "Animist Farm" property is a small section of a larger property owned by **SONNY's** live in partner. She has provided the property to **DAVID** and **SONNY** pursuant to a lease of 30 years for the sum of USD 3,000 (three thousand U.S. dollars) for the period of the lease.

Provided by **SONNY** and attached hereto are document copies of:
Bank statements tax payer information;
Corporate disclosures describing **SONNY's** and **DAVID's** assets; and
The Animist Farm Lease.

Subsequent to **SONNY** acquiring **DAVID's** phone he has also contacted various individuals in Canada to disclose all his knowledge concerning the matters of **DAVID's** disappearance and maintains offering assistance to obtain the whereabouts of **DAVID**.

On February 22, 2014 **SONNY** attended an interview at Military Police Headquarters, Siem Reap where he was interviewed regarding the matters of **DAVID's** disappearance. After the interview the Immigration Police also attended.

On February 22, 2014 **SONNY** was interviewed by **Allison Catmur**, Second Secretary (Management) and Vice Consul, from the Embassy of Canada, Bangkok, Thailand regarding the matter of **DAVID's** disappearance.

On February 23, 2014 **SONNY** acting on information he had obtained visited an Administration Police Officer named '**Chard**' at Chriev Village seeking the whereabouts of **MS** who informed **SONNY** that **MS** had departed the village several hour previously. **Chard** further stated he was highly suspicious of **MS's** behavior for several reasons one of them being that because he understood **MS** to be a well off foreigner who was residing in a very poor area, mixed with no one and maintained a rigid routine as if he was seeking to establish an alibi. **Chard** then introduced **SONNY** to the owner of the premises in which **MS** had stayed and when asked if she was aware of where **MS** had gone she stated **MS** had divulged he was going to Phnom Penh to visit his sister.

On February 24, 2014 **SONNY** advised Siem Reap Military Police of his findings regarding **MS**, however when he asked if the M.P. were going to apprehend **MS** as by now the M.P. must be aware **MS** was a person of interest in the matter the M.P. stated they would not because of the lack of manpower.



On the p.m. of February 24, 2014 **SONNY** held a telephone conversation with **MS** during which:

Because of the total lack of concern **MS** had displayed regarding **DAVID**, and regarding the professed **MS-DAVID** thirty year friendship which **MS** had shown to have disregarded, to test **MS** further **SONNY** asked **MS** if he agreed that they should post notices providing a reward for information leading to the whereabouts and/or well being of **DAVID** to which **MS** replied "okay" and he would be returning to Siem Reap within a few days to assist **SONNY**; and

However when **SONNY** inquired as to **MS's**, whereabouts **MS** stated he was in Phnom Penh arranging his passport and was about to return to Canada.

On February 26, 2014 **SONNY** received a telephone call from **MS** stating **MS** was very displeased he had been interviewed by the Military Police regarding the disappearance of **DAVID** and considered it highly inappropriate that **SONNY** had provided the M.P. with **MS's** details.

On February 28, 2014 **SONNY** received an email from **Peter Vronsky** stating **Vronsky** had been appointed the spokesman for **DAVID's** family and provided disclosures regarding **MS** and the **MS** family residing in a property **DAVID** had previously purchased in Keswick, Canada. Attached is the email from **Vronsky**.

By this time **SONNY** was aware that he was the prime suspect in the disappearance of **DAVID** and was now under scrutiny by elements of the Immigration and Military Police. **SONNY** was also made fully aware his partner (wife) had also become a suspect.


On March 1, 2014 **SONNY** attended the M.P. HQ during which time he turned over **DAVID's** phone to the M.P. who later provided the phone to the Immigration Police.

On March 3, 2014 **SONNY** received a further email from **Vronsky** in which **Vronsky** alternately berates and demands assistance from **SONNY**. Attached is the further email from **Vronsky**.

On March 4, 2014 **SONNY** was advised by Immigration Police that representatives of Canadian Law Enforcement were in Siem Reap liaising with Cambodian Law Enforcement regarding the matter of **DAVID's** disappearance however **SONNY** remains surprised that the Canadian Law Enforcement officials have not asked he present himself for interview.

On March 5, 2014 at about 1900 **SONNY** was astounded and later outraged to receive a telephone call from an individual stating he was the O.I.C. Siem Reap Military Police, **Srey Youra (015 888 837)** complaining that he was in trouble and out of favor with **AL** because **AL** was questioned by the Siem Reap M.P. regarding **DAVID's** disappearance and that **Srey Youra** had in response to this from **AL**, stated to **AL** that the M.P. were only questioning **AL** because it was necessary Police procedure. **SONNY's** response to this was **SONNY** was not bound by any matters regarding the relationship between **AL** and **Srey Youra** and why was he being notified of this when it is paramount **AL** SHOULD be questioned regarding **DAVID's** disappearance as **AL** should be a prime suspect or at the very least a person of interest? **SONNY** received no reply.
